- Understanding the causes and consequences of criminal behavior
- Contributing to the development of effective interventions for victims and offenders

# Offenders ...



- What happened, why?
- How can repeat offending be prevented, what do offenders need?

... and victims!

- How does that affect the victim(s), what do they need?

# Crime & psychological vulnerability – foundation course

What is a crime, an offender, a victim

Which (clinical) psychological factors might explain crime,  
 its causes and consequences

e.g., aggression, impulsivity, antisocial cognitions,  
 substance abuse, psychopathy, vulnerability for psychosis,  
 sexual interest, trauma, grief, coping, resilience



- › .... you will read about the violent encounter between Lotte Kroes and Jaap Smit. It landed Jaap in hospital, and, upon recovery of his health, in prison to await his trial. Jaap has an extensive criminal record (55 convictions: property, drugs related, vandalism, aggression and violence, first conviction at 13 years of age). The '*Rechter Commissaris*' (Investigating Magistrate) is concerned about Jaap's criminal career and requests a mental health assessment to help the judge decide on her sentence: will it be prison or treatment?



## **Crime & psychological assessment and interventions – foundation course**

The theory of clinical forensic practice with victims and offenders:

- › What is risk assessment, risk management, how is it done, and why?
- › What are effective interventions for offenders, for victims? Why?
- › How can we detect deception and malingering?



- › Willem Sterk receives a registration form regarding a new client:
- › sentenced by the court to a partly suspended prison term
- › sexually abused his 12-year-old daughter for a period of six months
- › unemployed and presently living with his wife and his 8-year-old son
- › requested: treatment for mood disorder and excessive use of alcohol



- › Willem also has a 12-year-old daughter. As he is reading the registration form, he is wondering how someone can abuse his own child. He is also wondering whether he is allowed to refuse to treat such a client.





- › Willem decides to treat the man, but during their first session he realizes quite quickly that the client does not want to talk about the sexual abuse, because he is too ashamed of it. What to do next? Willem has some knowledge about sex offender typologies, and he is an expert in motivational interviewing, but how can he deal with this situation?



## Clinical forensic skills – skills lab

Go and do it:

- › read a patient file and make a state of the art risk assessment
- › deal with that aggressive client in your first intake
- › motivate client to participate
- › challenge client's dysfunctional cognitions
- › assess whether client might be suicidal



## **Capita Selecta's in CFP&V and KP**

Read a set of specialized literature and take an (oral or written) exam. Topics e.g.:

- › PTSD
- › What works for offender rehabilitation
- › Child abuse and neglect
- › Psychopathy, the construct
- › Offender and victim amnesia
- › Disgust and sexual excitation
- › Risk assessment and threat analysis



## Master thesis, e.g.:

- › Factors contributing to school shootings
- › Living with the disappearance of a loved one
- › Public opinions about pedophilia
- › Victims becoming offenders
- › Police interviewing techniques
- › Filicide: when parents kill



## Internships

- › Objective: get to know a professional work setting and get some practical experience as a professional
- › Scope 10 or 20 EC, activities match with the content of the forensic master track
- › Own responsibility to find an internship, RuG facilitates
- › In May, prospective master students receive more specific information, e.g. requirements for internships
