Extended Oral Resit Examination Regulation 2018-2019

Article 1 General

- 1.1 An extended oral resit examination is an extension of the (resit) examination already taken. Students whom are in their first registered year of one of the Faculty's bachelor's degree programmes are eligible for an extended oral resit provided they fulfil the requirements.
- 1.2 Students whom are in their first registered year for the first time for one of the Faculty's bachelor's degree programmes include students who have started the propaedeutic phase of that programme per September of the current academic year and first year students of a pre-master's degree programme whom have to participate in a course which is part of the propaedeutic phase of one of the Faculty's bachelor's degree programmes are eligible.
- 1.3 For the Dutch-taught bachelor's degree programme the following courses offer an extended oral resit possibility: 'Algemene Rechtswetenschap 1', 'Rechtsgeschiedenis', 'Staatsrecht 1', 'Algemene Rechtswetenschap 2', 'Bestuursrecht 1', 'Burgerlijk Recht 1', and 'Strafrecht 1'. For the English-taught bachelor's degree programme the following courses offer an extended oral resit possibility: Law and Legal Skills: the Dutch example, Criminal Law, Introduction to International and European Law, Legal History, Introduction to Public Law, and Introduction to Technology Law.

Article 2 Requirements and result

- 2.1 Only students in their first year of registration, who have participated to both examination chances offered and who have scored at least a four (4) in the exam and a five (5) in the resit, are eligible for the extended oral resit examination. No exceptions are made to these requirements.
- 2.2 If the result of the extended oral resit examination is sufficient, the resit examination grade will be changed from a five to a six. In case of an insufficient result the already obtained five remains unchanged.

Article 3 Execution The dates of the extended oral resit examinations have been published before the start of the academic year in the examination schedule, which is available in the Law Knowledgebase. Considering the fact that it concerns an extension of an examination, the continuation of the assessment should take place soon after the resit examination. As soon as the result of the relevant resit examination has been published, a selection will be made of all students who are eligible to participate in the extended oral resit examination. Students who fulfil the requirements of Article 2 will receive an email in their University email account which holds more information about location and time; this email is sent three days before the extended oral resit examination at the very latest.

- 3.2 Enrolment for an extended oral resit examination is not possible.
- 3.3 If students do not participate in the extended oral resit examination, the original grade will remain registered as a result for the resit examination. If students cannot participate in the extended oral resit examination due to demonstrable force majeure, they can, if wanted, send a request to the Board of Examiners; they will then decide if those students are eligible for an extended oral resit examination at a different time.
- 3.4 The extended oral resit examination will be conducted by two lecturers and takes at least 15 minutes.
